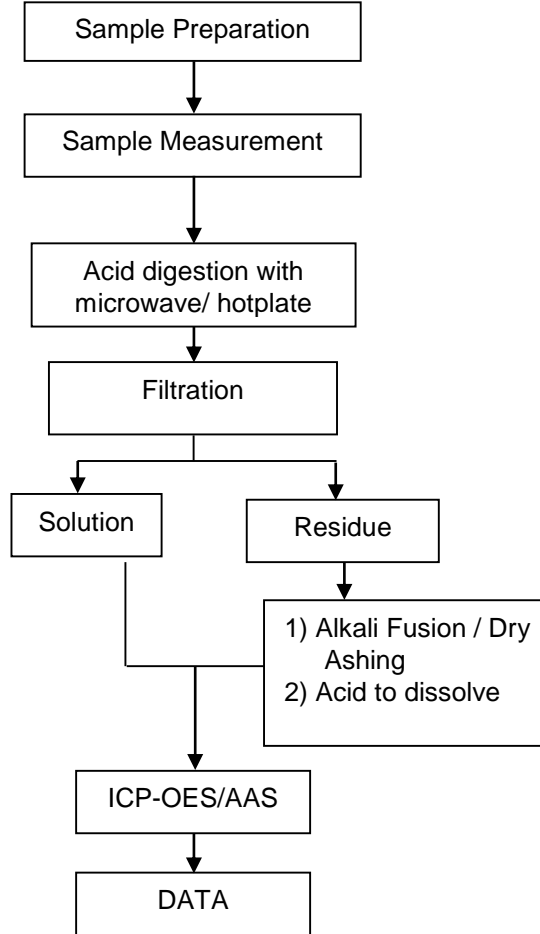

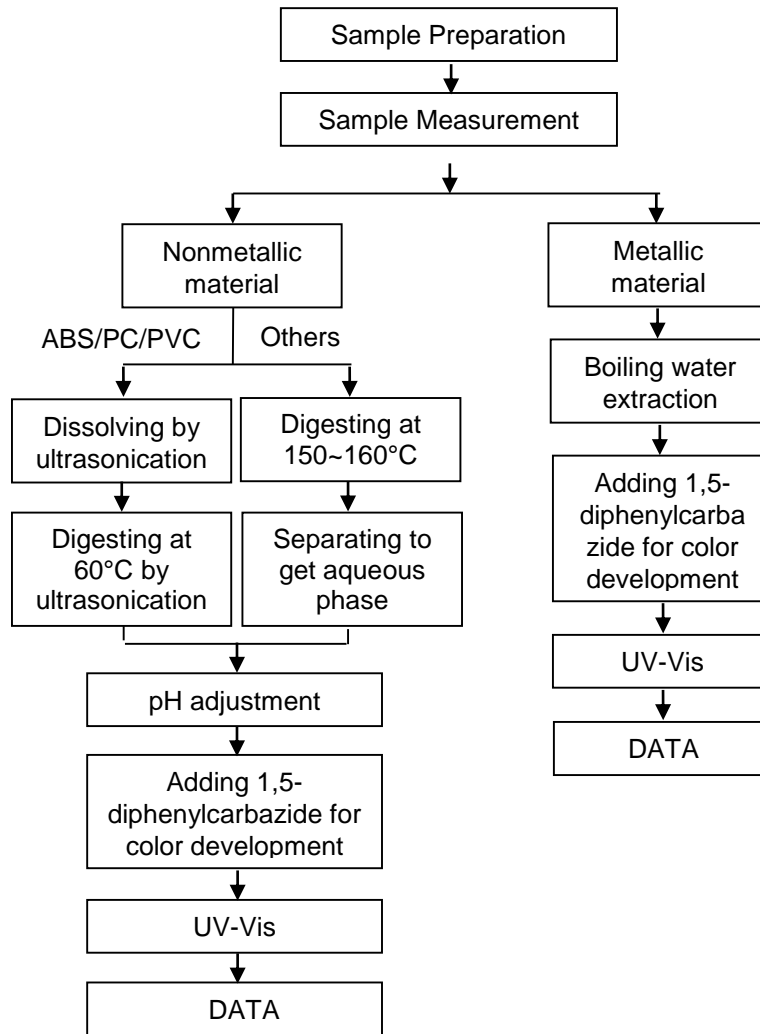

**Hexavalent Chromium (Cr(VI)) Testing Flow Chart**

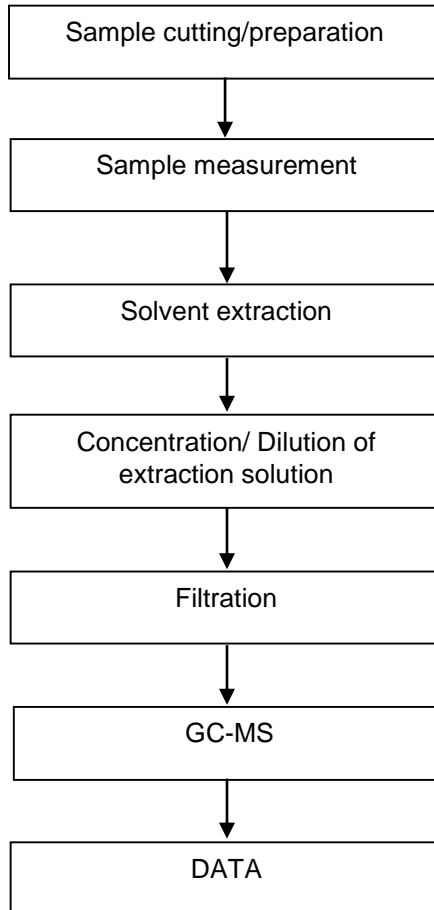

**PBBs/PBDEs Testing Flow Chart**



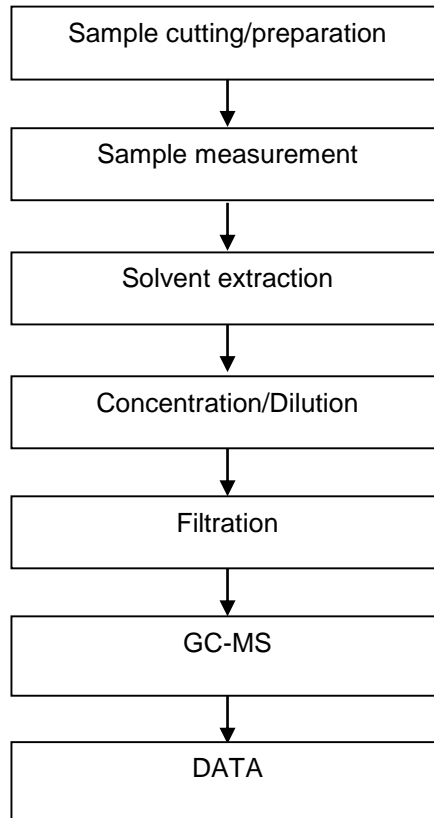
